We are so very fortunate to call San Diego home, with the beautiful Pacific Ocean as our backyard. Sunshine and shorelines create a unique backdrop for pursuing your life's goals and dreams, and Mission Fed is here to support you—at every stage of your journey. We believe "a rising tide lifts all boats." So, we are constantly looking for new ways to elevate our services, enhance the financial success of our members, and better serve our community.

Our members-first mindset and commitment to service inspires everything we do, and it continues to drive Mission Fed's growth and success. At year-end, we're proudly serving 240,176 members from 31 full-service branch locations. Total assets eclipsed \$3.5 billion in 2018, thanks, in part, to a 4.7% rise in member deposits.

"Rising to new heights" not only allows us to roll out new and improved services and stay at the forefront of banking technologies, but it also keeps Mission Fed operating on a solid financial foundation. In 2018, our strong capital position rose from 12.46% to 13.18% high above the 7% benchmark the National Credit Union Administration (NCUA) requires for a credit union to be "well capitalized." Along the way, we surpassed our goal for loan production by \$37 million, leading to overall loan growth of 12.3% compared to 2017.



New Headquarters, Brighter Horizons

Our management team is now guiding the efforts of over 563 dedicated Mission Fed employees from The Horizon Center, our new, cost-efficient, corporate headquarters on Meanley Drive in beautiful Scripps Ranch. From a service perspective, our horizon has never looked brighter. Service achievements in 2018 included mobile banking enhancements, a new HomeAdvantage® partnership, chip-enhanced debit cards, a Quick-Apply feature for credit cards, auto and personal loans, Instant Short-Term loans, and so many more.

New Heights of Community Engagement

Each year, Mission Fed takes great pride in supporting hundreds of special events to benefit our community partner organizations and the educational community. Events in 2018 that were particularly close to our hearts were: Go Red for Women and the American Heart Association, Food 4 Kids Backpack Program and the San Diego Food Bank, Girl Scouts San Diego, McGrath Family Biztown and Mission Fed Finance Park with Junior Achievement.





SUPERVISORY COMMITTEE REPORT ACHIEVING FINANCIAL HEIGHTS

Mission Fed's Supervisory Committee is comprised of volunteer members who have the financial responsibility for the internal and external audit activity of Mission Federal Credit Union. This year's committee members include Scott Patterson, Tina Douglas and myself.

Mission Fed undergoes an extensive oversight process by the NCUA (National Credit Union Administration) regulators, external auditors and the internal audit team. We enlisted the services of the external audit firm, CliftonLarsonAllen (CLA), to conduct the credit union's financial statement audit as of 12/31/18.

We are pleased to share with our membership that Mission Fed is in excellent financial condition. The 2018 consolidated financial statements were issued with an unmodified opinion, which is the best audit opinion the credit union can receive. Mission Fed maintains a strong net worth, has solid internal controls in place, remains well capitalized and continues to grow.

Mission Fed is also compliant with federal regulations and undergoes various compliance assessments throughout the year. Mission Fed continues to make appropriate process and policy changes to prepare for accounting changes, such as CECL (Current Expected Credit Loss), cybersecurity risks and new rules and regulations.

The credit union's commitment to ensuring strong financial reserves, sound business practices and dedicated leadership enables us to manage changes in the economic and regulatory environment, while maintaining a healthy financial position poised for continued growth.
