## WHAT DOES MISSION FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

## Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do. The types of personal information we collect and share depend on the product or service you What? have with us. This information can include: Social Security number and account balances purchase history and checking account information transaction history and wire transfer instructions When you are no longer our customer, we continue to share your information as described in this notice. All financial companies need to share customers' personal information to run their everyday How? business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Mission Federal Credit Union chooses to share; and whether you can limit this sharing.

What we do		
How does Mission Federal Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.	
How does Mission Federal Credit Union collect my personal information?	We collect your personal information, for example, when you  open an account or apply for a loan  make a wire transfer or pay your bills  use your credit card or debit card  We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.	
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>sharing for affiliates' everyday business purposes— information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing. Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  Our affiliates include Mission Federal Services, LLC; LiveSmart Insurance Services, LLC; and LiveSmart Escrow Services, Inc.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  • Mission Federal Credit Union does not share with nonaffiliates so they can market to you.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul> <li>Our joint marketing partners include providers of financial products and services such as investment and insurance products.</li> </ul>	

## Other important information

For California members, California law gives you the right to opt out of certain sharing. Please see the notice entitled, "Important Privacy Choices for Consumers." If you wish to limit our sharing, please complete the California Notice to restrict us from sharing your personal and financial information with our affiliates and outside companies that we do business with.
