

**Mission Federal Credit Union Chula Vista Branch  
Grand Opening Prize Drawing Official Rules**

**1.NO PURCHASE NECESSARY TO ENTER. PURCHASE DOES NOT INCREASE ODDS OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW**

**2.How to Enter:** Visit the Mission Fed Credit Union (“Mission Fed”) Chula Vista Branch (1170 Broadway, Ste. 110, Chula Vista, CA 91911) during branch business hours any day from Monday, September 19, 2022 through Saturday, October 1, 2022 (“Entry Period”) and complete an official Entry Form. **One entry per person. One daily prize per person. Daily prize winner will also be eligible for Grand Prize which will be drawn on 9/26/22.** Anyone who submits multiple entries will be disqualified. Entries become the property of Mission Fed Credit Union and will not be returned.

**3.Prizes and Odds of Winning:** Grand Prize: \$500 cash (one). Daily Prize: There will be one (1) drawing per day for \$100, for a total of six (6) prizes during the Chula Vista Grand Opening Entry Period. Winners will receive a cash deposit into their Mission Fed account or \$100 Visa Gift Card if they do not have a Mission Fed Account. Odds of winning will vary depending on the number of entries received. Prizes are non-transferable.

**4.Prize Drawing:** After the branch closes each day during Chula Vista Grand Opening Entry Period, a winner will be drawn and contacted within 48 hours. Winners need not be present to win. Winners must claim their prize within one (1) week or a new winner will be selected. For names of the winners, send a self-addressed stamped envelope to Chula Vista Grand Opening Drawing, Mission Fed Credit Union, P.O. Box 919023 San Diego, CA 92191-9023. All Fed, state and local laws apply

**5.Eligibility:** To qualify for the drawing, all entrants must be U.S. residents age 18 or older. Winners must be able to provide verification of identity and age. By entering this drawing, entrants accept and agree to be bound by these Official Rules and the decisions of the Mission Fed Credit Union. Drawing void where prohibited by law.

**6.Liability and General Rules:** Entrants agree to hold Mission Fed Credit Union and each of its officers, directors, employees, members, representatives and agents harmless from any liability arising from participation in the Mission Fed Credit Union Chula Vista Grand Opening Drawing. Mission Fed Credit Union is not responsible for any negligence, claims, liability, injury, property loss or other damages arising from, or in connection with, acceptance or participation in any of these drawings. Further, Mission Fed Credit Union is not responsible for any incorrect or inaccurate information, lost, incomplete, illegible, late, misdirected, stolen, or mutilated entries or other materials or bona fide human processing errors. Mission Fed Credit Union reserves the right to disqualify entrants who fail to follow these Official Rules and regulations, who tamper with the entry process, or who make any misrepresentations relative to this drawing. Mission Fed Credit Union shall have the absolute right to determine if an entry is in compliance with these Official Rules without notice to the person attempting to enter.

**7. Tax issues:** Taxes due on the prize are the sole responsibility of the recipient. Mission Fed Credit Union will report all prize winnings to the appropriate state and Fed agencies as required by applicable law. Winners, as applicable, are responsible for tax consequences (if any) of the prize.

8. Employees of Mission Fed Credit Union, affiliates and their immediate family members are ineligible to participate or win. Immediate family members include: spouse, domestic partner, cohabitants, parents, grandparents and great-grandparents, children and grandchildren, brothers and sisters, mother in law and father in law, brothers in law and sisters in law, daughters in law and sons in law, aunts, uncles, nieces, nephews and first cousins (that is, a child of an aunt or uncle). Adopted, half, foster, and step members are also included as immediate family.

**9. Publicity Authorization:** The winner agrees to permit Mission Fed to utilize their name, photo, video and likeness in promotional and other Mission Fed materials, without additional compensation or permission, except where prohibited by law. The winner also grants Mission Fed Credit Union, its employees, designees, agents, independent contractors, legal representatives, successors and assigns, and all persons from whom or through whom it is acting, the absolute right and unrestricted permission to take, use their name, their voice, testimonial and biographical data and/or publish, reproduce, edit, alter, copy, exhibit, project, display and/or copyright photographic images or pictures of them or their child(ren) whether still, single, multiple, or moving, or in which they may be included in whole or part, in color or otherwise, through any and all forms of media (print, digital, electronic, broadcast, social media including but not limited to, Facebook, Instagram, Twitter etc.), for art, advertising, marketing, publicity, archival and any other lawful purpose. The winner understands and agrees that these materials will become the property of Mission Fed Credit Union and will not be returned.

10. Mission Fed Credit Union reserves the right to suspend or cancel the promotion or modify these Official Rules as necessary for any reason or as required by applicable law. Mission Fed Credit Union reserves the right, at its sole discretion, to disqualify from the promotion, and ban from any future promotions, any person they believe is to have intentionally violated these Official Rules or tampered with any element of the promotion without notice to the disqualified or banned person.
